CHAIRMAN'S REPORT

I have a few reminders for everyone, as it is the start of a new year.

Chapter Presidents, you only have a few days to get your registration packets turned into International. Also, Conference dues are again due, one dollar per member, with a max at \$25.00. Mail the Conference dues to MWRC Secretary / Treasurer, Tom Ashing, at PO Box 890095 Oklahoma City, OK 73189.

Also, remember each chapter must file a tax return with the IRS to keep your tax exempt status.

The early registration cut off for the 2015 International Convention in Reno, NV is February 1st. After February 1st, the registration increases from \$150.00 a person to \$175.00 a person. Information is available on the MWRC Webpage, as well as the International Webpage.

MN-IV is hosting the Spring MWRC in Eagan, MN. The registration is \$75.00 until April 30th, then increases to \$85.00. For more information see their article in this newsletter or go to the MWRC Webpage. The Fall MWRC will be hosted by IA-III in Davenport, IA. They also have a short update article later in this newsletter. The Spring 2016 MWRC will be hosted by IA-VI in the Ottumwa, Iowa area. At the Fall 2014 MWRC no chapter put in a bid for the Fall 2016 MWRC so it, as well as the Spring 2017 MWRC, will come up for bid at the Spring 2015 in Eagan, MN.

Also, remember that 2015 is an International election year, so make sure your addresses are correct on the 2015 renewal packet.

I hope to see each of you at the Spring MWRC, if not before.

INTERNATIONAL REPRESENTATIVE REPORT



International **Representative's Report**

There has been one special meeting and two regular BOD meetings since the Fall newsletter. The highlights of the meetings are below. If you would like additional details, the BOD minutes are posted in the "Members Only" section of www.blueknights.org when approved. (The user name is your membership number and the password is your last name in capital letters). I send the minutes to each chapter as they become available and request they send them on to each chapter member.

NOVEMBER 8^{TH} , 2014 - BOARD OF **DIRECTORS SPECIAL MEETING:**

There were two agenda items on the Special Meeting, the hiring of an audit firm and the disciplinary appeal hearing of Michael Broman -LA VIII.

After considering 3 firms, the board voted to hire the firm of Edwards, Faust & Smith to conduct the audit. This firm was local but was not the accounting firm presently doing some work for the International. It is my understanding that the firm has begun its work.

Michael Broman presented his appeal. This case was somewhat unique as unlike most disciplinary actions where any suspensions or

punishments do not take effect until after the appeal process is over, Mr. Broman was suspended by the International President DJ Alvarez many months prior. This suspension was never ratified by the BOD as required under our by-laws. The appeal was actually an appeal of a decision of the Southern Conference but there was confusion due to the suspension by the President. Mr. Broman was never advised of his appeal rights to that suspension. At the conclusion of the hearing, the BOD decided in favor of the SRC but the discipline would be time served and his membership rights would be immediately restored.

NOVEMBER 12TH , 2014 - BOARD OF DIRECTORS MEETING:

- Prior to the meeting I resigned from the Bylaw Committee. I had been approached to chair the committee at the International Convention by President Alvarez. I was advised then that I was to run the committee as I saw fit and only needed to keep the President up to date on our The committee was working progress. hard and making progress but I was advised that President Alvarez reversed his approval of an appointee I chose for the committee. I did not appreciate the interference, especially since it appeared to be of a political nature and I took the job based on his assurance that I would be able to run the committee without being micromanaged. As his decision was unwavering, I resigned. Bob Flanagan was appointed to fill the position.
- Treasurer John Gordon presented the 2015 budget. Budget passed. 14 yes, 1 no – NEC, 1 abstention – MWRC.
- AR IV is in the red from the 2013 International Convention and has requested a loan of \$5,875.41. Approved – 16 yes, 1 no – RGC.
- VP Bryan reported total membership at 19,573 in 626 chapters. The MWRC has 956 in 35 chapters.
- President Alvarez asks that all chapters complete the membership survey and send back with the renewal packet.

Old Business:

Proposals 2014-0008, 0009, 0013, 0014 & 0015 were tabled.

New Business:

<u>2014-0016</u>: BOG proxy voting. Motion died for lack of a second. The proposal rightfully should be passed by the BOG first before it is to be taken up by the BOD.

<u>2014-0017:</u> Constitution Article 6. Add Electronic voting. Withdrawn by the TSC.

<u>2014-0018</u>: To amend bylaw 3.16 to allow voting by electronic means. President Alvarez would not allow a vote of the proposal as he claims it is still illegal in the State of Maine to use electronic voting. An email was produced from an attorney in the Maine Attorney General's Office which gave the decision that electronic voting was permissible if it was in the bylaws. That email was deemed to be insufficient proof and a vote was not allowed.

<u>2014-0019:</u> Approve a one-piece patch. Approved as an alternative.



<u>2014-0020:</u> To allow Jim Beam the use of the corporate logo for use in a limited edition "Booker's Special Batch bourbon". Approved.

2014-0021: To introduce and use an enhanced, security

type, mailed out paper ballot election system for the 2015 Blue Knights International Election. The GLRC withdrew the proposal.

Conference Reports: See minutes.

<u>Good of the Order:</u> Please be aware of the early registration date for the International Convention in Reno. <u>Early registration ends on Feb 1, 2015.</u>

JANUARY 10TH , 2015 - BOARD OF DIRECTORS MEETING:

- Headquarters the basement needs repairs and an addition needs to be considered. The addition can house additional office space and have a museum section. Around \$100,000 was donated some years ago for a museum section. A motion was approved to obtain estimates.
- Audit President Alvarez and Mike Gratis met with representatives of the audit firm just prior to Christmas. There was a motion to retain the present accounting firm for accounting services – approved. President Alvarez had wished to hire the audit company to take that over however he was told that would be a conflict of interest and would bar the audit firm from any subsequent audits. I made a motion to have an audit done every two years but was asked to withdraw until the audit firm gives their recommendations. I agreed.
- Convention update The host hotel is full and all future reservations will be at the Silver Legacy. The hotels are connected. Early registrations end February 1st. Please register soon. Refunds are not a problem.
- The Scholarship Committee is deciding on a topic. They should be open for submissions soon.
- The three International Honorary members were approved.
- Treasurer Gordon the completions of the year-ends are approximately 2 weeks away. Europe has paid back the convention loan. The financial paperwork looks okay to him.

<u>Old Business:</u> Proposals 2014-0008, 0009, 0013, 0014 & 0015 were withdrawn.

New Business:

<u>2015-0001</u>: Extend the period for new members to purchase a motorcycle from 6 months to a year. Died for lack of a motion to approve.

<u>2015-0002:</u> Membership at Large. Approved with amendment changing "headquarters or mailing address" to "charter location". The 50 mile rule remains in place. Adds verification of qualification to the Conference. This portion supersedes a policy.

<u>2015-0003</u>: To amend the Constitution Section 2. Associate Membership. Passes with amendments. Constitutional changes do not take effect until passed by a ³/₄ majority at the next International General Meeting.

<u>2015-0004</u>: Renewing members of the Military Reserves called to full-time duty prior to January 31, 2015 would be eligible to have their 2015 dues waived. No refunds if you have already paid. There was a discussion to have future versions of this proposal heard earlier in the renewal process.

2015-0005: Proposal to fund the mandatory switch from the Australian back patch to the new one piece back patch in the sum of \$3,000. Amendments included splitting the cost with the West Coast Conference \$1,500 each. I added an amendment that any Australian member seeking reimbursement must turn in an illegal Austria back patch. Passed. For those of you not familiar with the controversy, some years ago, an Australian president submitted a design for a front patch which was approved. Members were told that the design was approved for a back patch and began producing them. Australia has very strict motorcycle club laws but that back patch was approved bv the Police By the time this was Commissioners. discovered, the back patch was ingrained in the Australian chapters and resistance and cultural differences were present. Some Australian members were removed from the Blue Knights. Many members purchased the illegal colors in good faith and this proposal was an attempt to repair any damages that have ensued. This is a very short description of a complex issue but it was apparent that there was enough blame to go around between the Australians, the West Coast Conference and the International. The distance and isolation did not help matters.











The next BOD meeting was set for April 1st at 0900 CST. The deadline for agenda items is March 13th.

SAFETY REPORT



WINTER SAFETY INFORMATION

Restoring that old motorcycle helmet you love will give it back some semblance of its former glory. Although it may not be possible to remove all blemishes, motorcycle helmets can easily be spruced up. It is important to replace your helmet if it is dented, cracked or has major damage as this compromises the protective abilities of the helmet.

Restore your helmet, if it only has superficial damage, bv washing it, touchina uр scratches and replacing the visor, worn lining and straps.

You will **Need:**

Replacement visor, lining and straps Nail polish remover or rubbing alcohol Mild dish washing soap Soft towels Automotive touch-up paint Small, round paint brush Rubbing compound Microfiber cloth



Instructions

Contact the manufacturer of the helmet to order replacement items (visor, lining and straps) that are appropriate for your particular helmet. Replace them according to the manufacturer's instructions.

Remove any stickers with nail polish remover or rubbing alcohol. Saturate the stickers and allow the alcohol to soak in, then rub them off with a towel or rag.

Wash your helmet with a towel soaked with soapy water to remove any dirt and grime. Use a mild dish washing detergent. A helmet cleaning foam can also be used.

Touch up scratches with automotive touch-up paint. Automotive touch-up paints come in a wide range of colors, and more than likely you can find colors that match those on your helmet. Use a small brush to carefully paint over scratches.

Polish the helmet with rubbing compound. Rubbing compound will give the helmet a shine and will help to fill and hide scratches. Buff the helmet with the rubbing compound using a microfiber cloth, working the surface in circular motions. Apply light to medium pressure and do not over-polish the helmet as this can cause clouding on the surface.

THEN – WEAR your helmet in 2015.



Motorcyclist fatalities, injuries decline in 2013

PICKERINGTON, Ohio -- The National Highway Traffic Safety Administration says the number of motorcyclists killed in traffic crashes declined by 6.4 percent from 2012 to 2013, and the number injured dropped 5.4 percent, the American Motorcyclist Association reports.

In 2013, 4,668 motorcyclist fatalities were reported, down 318 from the 4,986 in 2012. Similarly, 88,000 "occupants" were reported to have been injured in motorcycle crashes in 2013, down from 93,000 the year before.

The NHTSA also reported that motor vehicle crash fatalities overall decreased by 3.1 percent in 2013 and injuries declined 2.1 percent.

"While one motorcycle fatality is one too many, we are pleased to see this number decline," said Rob Dingman, AMA president and CEO. "It also is good that motorcycle injuries and fatalities are falling at a greater rate than for motor vehicles overall. And we sincerely hope this trend continues."

One factor in the lower incidence of motorcycle crash fatalities was an 8.3 percent decrease in the number of motorcycle crashes in which the rider was impaired by alcohol, the NHTSA reported.

The NHTSA report also noted that there were 190 fewer fatalities in 2013 among motorcyclists aged 50 to 69 years. That decline represented 60 percent of the total decrease in motorcyclist fatalities.

"Motorcyclist safety is of utmost importance," Dingman said. "That is why the AMA is participating in the Motorcycle Crash Causation Study underway at Oklahoma State University. We hope that the information from this extensive examination of motorcycle crashes will lead to better strategies for making our roads safer for motorcyclists."

The Motorcycle Crash Causation Study is the first comprehensive examination since the 1981 Hurt Report on the factors contributing to motorcycle crashes in the United States.

When the project is completed in 2016, it will provide a large and unique data set derived from actual motorcycle crashes and riders with similar risk characteristics, with a focus on the unique circumstances that produce motorcycle crashes.

The Motorcycle Crash Causation Study will provide up-to-date information on the types of dangers modern motorcyclists face. The study is important, because it will provide new insights into which factors affect motorcyclist safety and how.
